Thank you for your interest in Horn Creek – a unique experience that combines rocky mountain accommodations with spiritual refreshment for a Christian perspective. Challenger Point family camp is a three-night experience in which you will enjoy hearty meals served to you; fun activities and programming for the whole family; and our Round Up time, which follows our evening meals and is a great time of worship and hearing God’s Word from one of our dynamic speakers. We even include a bountiful Thanksgiving dinner with family and friends!

I’d like you to know more about some special things for this year’s camp that we call “**Challenger Point**”:

- The camp will run from Wednesday, November 24th (4:00 – 6:00 p.m. check-in) through Saturday, November 27th(check-out after breakfast).
- A family of 4 (2 adults, 1 teen and 1 child) can attend the entire camp for **as little as \$760** total.
- Recreation activities that will be available include: Indoor Rock-Climbing Wall\*\*, Bowling\*\*, Basketball, Racquetball, Walley Ball, Indoor Running/Walking Track, and Weight Training Equipment. \*\*Fees apply
- As always, we’ll enjoy a lot of fun together for the Thanksgiving Holiday with plenty of activities and programming that the whole family can get involved in!

So you might ask, what happens between breakfast and dinner? Horn Creek offers many opportunities for families to spend quality time together. Our fees include some basic recreational programs for your enjoyment including access to our Recreation Center which features basketball, volleyball, racquetball and an indoor track. Outdoor we provide opportunities to race down the tubing hill and enjoy the beautiful snow as weather permits. For nominal fees, several other Horn Creek activities are available including a 30’ indoor climbing wall, bowling, snowshoeing, gift and snack shops. Of course, there’s always an opportunity to cozy up to a warm fire and enjoy a cup of hot cocoa and a good book!

A Family Camp Registration Form for this camp is enclosed. We encourage you to send in your **\$200 non-refundable deposit** along with the enclosed registration form at your earliest convenience to secure your spot in camp.

To simplify your registration process, we are charging a basic, per-person fee this year. We will match your family with the room that best fits your family size. *If you have special housing needs, let us know in the designated space on the registration form.*

Before you complete and send in your registration form, please read carefully the following Horn Creek Family Camp policies. Your signature on the registration form indicates that you have read and understand these guidelines:

- **Payment for Camp** – Your \$200 non-refundable deposit should be submitted along with the registration form, unless other arrangements are made through our registrar. Half of the Total Camp Fees, less the \$200 deposit, is due 90 days prior to the start of your camp. The balance is due on the first day of your camp. Horn Creek now accepts cash, check, money orders, electronic funds transfers and credit cards as payment for camp. Please do not mail cash.
- **Cancellation Policy and Penalties -**
  - Cancellation 91 or more days before camp –\$200 deposit is non-refundable.
  - Cancellation 31-90 days before camp – 50% of Total Camp Fees are non-refundable if we are unable to fill your spot at camp.
  - Cancellation 0-30 days before camp – You are responsible for the Total Camp Fees if we are unable to fill your spot at camp.

Refunds of pre-payments will be given when they exceed the cancellation penalties listed above, and *we will refund any fee paid (less the \$200 non-refundable deposit) even after these penalty dates, if we can find someone to fill your space at the camp. Those refunds will be given upon the replacement campers' fees being paid. You may bring us that replacement family yourself, and in the event that you must cancel, we encourage you to do so!*

If circumstances require you to cancel your registration, contact Horn Creek immediately, and make sure you have confirmation from the Horn Creek registrar that your cancellation has been received. Horn Creek always takes into consideration medical or other family emergencies.
